**Expanded Bio 2 Year Subscription Fee: \$300
1/1/2018 Through 1/1/2020**

Expanded Biography Includes:

1. 500 word biography (CV)
2. Posting of your professional headshot
3. Opportunity to have your name appear with two additional "service type categories" in the directory (one listing is included with membership)
4. A link from your expanded bio to your company's website

Only the "expanded bios" are searchable by any word or series of words. For example, prospective users of receivership services might search for a receiver knowledgeable in the business which is the subject of a receivership. By listing in your expanded bio the many types of businesses in which you have performed receivership duties, your expertise will be easily accessed. Your bio showcases your expertise in types of Receiverships and industries served with your specialized experience.

Expanded bio postings are sold in blocks of 24 months beginning 1/1/2018 through 1/1/2020 for \$300. Those purchasing expanded bios after August 1, 2018 will be prorated for this 24-month period at a rate of \$15 a month remaining in the period. Expanded bios are paid in in one lump sum by check or credit card (page 2).
