**WHAT DOES IT COST TO JOIN?** \$125.00 for new members, \$100.00 for renewals, \$50.00 for receiver administrator or legal assistant (as long as the firm has a full price member), \$295.00 for 4 members from the same company, \$25.00 for government employees. Membership is free to judges and their staffs, but they DO need to complete a form. Members joining October through December receive their balance of this year, plus the next 12 months for the annual fee.
